1. Call to Order / Introductions

- 3. Approve Minutes of the October 12, 2021 Transportation TAC meeting

4. Transportation Alternatives Program (TAP) Project Selection

<u>Discussion:</u> Lynch shared at the January 27th Bicycle Pedestrian Sub-committee meeting, the members ranked the two projects that applied to the TAP funding. The committee ranked the projects in the following order: The City of Schofield project - Business 51 Pedestrian Bridge and Bypass Trail; and City of Wausau - Business Campus East-West Trail.

5. STP-Urban Scoring and Criteria Discussion and Possible Revisions

<u>Discussion:</u> Lynch refreshed the committee of the scoring and criteria from the previous years. Last year, the Wausau MPO established the STP-Urban projects be at 70% with the 30% is the sponsoring local government. A project that is below 55% federal level will not be funded and any other remaining funds will be distributed in rank order to bring projects to the 80% federal level. Included in the packet is the project eligibility and project scoring that was reviewed with the committee. No changes will be made for the FFY22 solicitation period but staff will develop ways to encourage quick completion of projects.

Wausau MPO Scoring update for STP funding

At the February TAC meeting, members were given the opportunity to provide feedback on the STP scoring used by MPO staff to rank projects applying for STP funds. The main feedback was to develop a way to encourage faster completion of projects to maximize available funding. It was decided to not apply any changes to the FFY22 solicitation, but to return with options for the FFY23 solicitation cycle. MPO staff has developed some options for the committee to consider:

Reduce the score of municipalities that already have funded projects.

Pros: Easy for staff to implement.

Con: 10% is an arbitrary number. What is the 'correct' number? Construction date is set by WisDOT.

Project Complexity

In this field, all projects start with 3 points. Deductions are made for involvement of Railroad, Environmental, or Right-Of-Way.

Example: Project X crosses the RR tracks but no environmental concerns and no ROW beyond curb ramps. Project X = 2 points

Pros: Addresses projects with more complex items

Con: Staff would make subjective measurements. Complex items often cannot be avoided.

No Change

The TAC can continue to work on this issue but make no changes for the FFY23 projects.




BIL Update – Projects for FFY22


Village of Weston Northwestern Ave Between CTH X and Village limits

Carbon Reduction Program Announcement

4/11/2022

Background

- The Bipartisan Infrastructure Law of 2021 (BIL) establishes a Carbon Reduction Program. This new federal program
 provides funding for projects that reduce transportation emissions and requires states to develop comprehensive
 carbon reduction strategies.
- Wisconsin's Federal Fiscal Year (FFY) 2022 estimated suballocation requirement for the Carbon Reduction Program is \$15.6M.
- The federal cost share on projects eligible for Carbon Reduction funding is 80 percent and 20 percent local share.
 Projects in areas over 200,000 population must be selected in coordination with the metropolitan planning organization that represents the urbanized area prior to obligating funding.
- This solicitation is to obligate funds to meet the FFY22 draft apportionments.

- WisDOT will utilize an expedited process to ensure that available funds are obligated by 9/30/22.
- TMAs representing population areas over 200,000 and MPOs representing population areas between 50,000 and 200,000 will pick their projects (\$8,689,886 of FFY22 funding) that meet eligibility guidelines for the Carbon Reduction Program.
 - MPOs should coordinate applications and submit selected projects to WisDOT by June 1st.

- For population areas less than 50,000 (\$6,883,171 of FFY22 funding), local units of government submit applications to WisDOT Regions (see end of document for a list of contacts).
 - Applications must include project cost estimate showing project cost eligible for federal reimbursement.
 The federal cost share is 80 percent and 20 percent local share.
 - WisDOT reviews and picks projects utilizing a discretionary selection committee structure similar to the Transportation Alternatives Program (TAP).
 - o Project award announcements are anticipated in June 2022.

Timeline

- Week of April 11 Carbon Reduction Program solicitation distributed to locals (Guidelines, Application, Application Instructions)
- Week of April 18 WisDOT holds informational webinar for Carbon Reduction Program
- May 6, 2022 Carbon Reduction Program application deadline
- May 2022 Project Selection
- June 2022 Project Awards

Project Eligibility

- Note Aug 1 PS&E would be required for all FFY22 construction projects.
- The following project activities are listed in the BIL as eligible for Carbon Reduction Program funding:
 - Establishment or operation of a traffic monitoring, management, and control facility or program, including advanced truck stop electrification systems (23 USC, Section 149(b)(4));
 - A public transportation project that is eligible for federal assistance (23 USC, Section 142);
 - Construction, planning, and design of on- or off-road trail facilities for pedestrians and bicyclists;
 - Advanced transportation and congestion management technologies (23 USC, Section 503(c)(4)(E));
 - Deployment of infrastructure-based intelligent transportation systems capital improvements and the installation of vehicle-to-infrastructure communications systems;
 - Replacement of street lighting and traffic control devices with energy-efficient alternatives;
 - Congestion pricing, shifting transportation demand to non-peak hours or other transportation modes, increasing vehicle occupancy rates, or otherwise reducing demand for roads, including electronic toll collection and transportation demand management strategies;
 - Efforts to reduce environmental and community impacts of freight movements;
 - o Deployment of alternative fuel vehicles and charging/fueling infrastructure;
 - Purchase or lease of zero-emissions construction equipment and vehicles;
 - Diesel engine retrofit projects as described in <u>23 USC</u>, <u>Section 149(b)(8)</u>;
 - A project that does not result in the construction of new capacity (23 USC, Section 149(b)(5);
 - Reduction of transportation emissions at port facilities, including through the advancement of port electrification: and
 - Projects eligible under the federal Surface Transportation Block Grant Program (23 USC, Section 133(b)),
 if the US DOT secretary certifies that the project will reduce transportation emissions.
