5. 2022 Transportation Improvement Program (TIP) Amendment

<u>Discussion</u>: Included in the meeting packet is a resolution with additions to the TIP. Table 1 of the 2022- 2025 Amendment of the TIP adds the changes so the projects can begin when planned. The following changes are the changes in the resolution:

- City of Schofield Feasibility Study Eau Claire River Bike/Pedestrian Study
- Village of Weston Bike/Pedestrian Plan Weston Bike Pedestrian Master Plan
- NC Wisconsin Village of Weston Safe Routes to Schools NCWRPC Safe Routes to Schools Weston Elementary School

6. 2023-2026 STP-URBAN PROJECT SELECTION

<u>Discussion</u>: Mack updated the commission on the STP-Urban projects that were submitted for funding. The listing of the funds were included in the packet. The Wausau metro will be receiving \$4.1 million and prior years received \$3.1 million. The Technical Advisory Committee went through the projects that were scored as follows:

- 1) Village of Weston and City of Schofield, Ross Ave from Metro Dr. Alderson St;
- 2) City of Wausau, W. Wausau Ave. from Tenth Ave. to Stevens Dr.;
- 3) Village and Town of Weston, Ross Ave from River Bend Paul's Rd;
- 4) Village of Weston, Schofield Ave. from Bus Hwy 51 to Birch St.;

- 5) City of Schofield, Ross Ave from Schofield Ave to Pine Rd.;
- 6) Town of Weston, Gusman Rd. from CTH J to Kramer Rd.

Staff provided some funding scenarios using different percentages of federal dollars.

Scenario 1 indicated providing projects 1, 2 and 6 with 70% funds with the remainder of the funds being distributed proportionally to the 3 projects. This provided all three projects with 74% funds on the projects in the end.
