1. Selection of Chair / Call to Order

In the presence of a quorum, with the agenda being properly signed and posted, the meeting was called to order by Vice-Chair Peterson at 2:03 p.m. in Room 5, 212 River Drive, Wausau, Wisconsin.

2. Welcome and Introductions

All were welcomed and introductions were made.

Peterson announced the Village of Rothschild received funding from the Municipal Street Improvement Program for the Margaret Street project.

Lynch reported on a conference he attended in Indianapolis hosted by People 4 Bikes, an industry-led advocacy group. The group unveiled a new scoring system to rate communities on their bicycle experience. The City of Wausau took 1st place in the Small Cities category and 2nd place Overall. Lynch thanked the commission for their work in the past years to include bicycle and pedestrian accommodations in their road projects and thanked Meurett for being a knowledgeable advisor in this area.

3. Commission Bylaw Changes Regarding Commission Leadership

Mack gave a briefing on the structure and establishment of the Metropolitan Planning Organization (MPO). The Commission is part of Marathon County structure and the county board chairperson appointments the chair and vice chair. When changes to the bylaws occurred in 1996, a clause was added that the chair would be someone who has been on the board for at least one year. Mr. Robinson was appointed Chair of the Marathon County Infrastructure Committee and then would also chair the MPO. The County Board will be reviewing the bylaws at their May meeting. A request to remove the sentence of "the chairperson must have served as a MPO member for one year immediately prior." has been submitted. The other change that was noted was in Article III of the bylaws was that the Town of Maine will be changed to the Village of Maine.

4. Approve Minutes of the April 10, 2018 meeting

Action: MOTION / SECOND BY FIFRICK / MULLALEY TO APPROVE THE APRIL 10, 2018 MINUTES AS DISTRIBUTED. MOTION CARRIED BY VOICE VOTE, NO DISSENT.

5. Public Hearing – Wausau Urban Area Sewer Service Plan, 2040

<u>Comment:</u> Peterson read through the public hearing notice for the Wausau Urban Area Sewer Service Plan. The public hearing was then opened. John Robinson, 1226 Highland Court, Wausau, Wi 54403 commented as follows: Many of the sections seem to be outdated with the plan being a 20 year plan, looking at the assumptions for the City of Wausau, relative to the acreage required in the future with the population density of over 3 residents per acre with most of the new development in the Fountain Hills and Franklin Heights area having less density. This would then drive up the acreage numbers in the sewer service area. With the updated County's Strategic Plan being concerned with the quality and quantity of ground water, and also making a change to the Environmental Impact Fund by using it to replace Private Onsite Waste Treatment Systems, the concern is the lack of background data and should there be more

current background data. The Mid-state and Gorski landfills could be used as some examples for a baseline.

Action: MOTION / SECOND BY FIFRICK / EMERLING TO CLOSE THE PUBLIC HEARING ON THE WAUSAU URBAN AREA SEWER SERVICE PLAN. MOTION CARRIED BY VOICE VOTE, NO DISSENT.

<u>Follow Through:</u> The hearing comments will be included as part of the Wausau Urban Area Sewer Service Plan.

6. Wausau Urban Area Sewer Service Plan, 2040

<u>Discussion</u>: Mack stated that due to the size of the Wausau Urban Area Sewer Service Plan, no additional copies were made. The plan is available for review on the Marathon County website and a 30 day public review period has been completed along with a Public Hearing.

Action: MOTION / SECOND BY GATES / FIFRICK TO APPROVE RESOLUTION 2-18, THE ADOPTION OF THE WAUSAU URBAN AREA SEWER SERVICE PLAN, 2040. MOTION CARRIED BY VOICE VOTE, NO DISSENT.

Follow Through: The Resolution will be included as part of the Plan.

7. Transportation Improvement Program (TIP) Amendment

<u>Discussion</u>: Mack discussed the performance based planning and programming from the federal transportation bills that will be included in the TIP. With the amendment, the TIP will include a 5 page document which consists of the following measure goals; Safety, Infrastructure Condition, Congestion Reduction, System Reliability, Freight Movement and Economic Vitality, Environmental sustainability, and Reduced Project Delivery Delays. The MPO has 6 distinct measures that will be addressed thoroughly. Some of the safety measures in the current TIP are traffic signals on Rib Mountain Drive, Railroad crossings in Schofield and antiskid antiresistance surfaces on area roadways.

<u>Action:</u> Motion / Second By Ermeling / Fifrick to approve resolution 3-18 amending the 2018-2021 transportation improvement program (TIP) for the wausau metropolitan area. Motion carried by voice vote, no dissent.

<u>Follow Through:</u> Staff will include the amendment in the TIP and send it to WisDOT and FHWA for their consideration.

8. Draft 2018 Transit Development Program (TDP)

<u>Discussion</u>: Lynch stated that the 2018 Transit Development Program public review period has been completed. Meetings were held in Wausau, Rothschild, and Rib Mountain in an effort to reach more transit riders for comments. The following changes were handed out by Lynch:

- Pg. 10 Remove Town of Texas from Table 4;
- Pg. 28 Added copy of mail Survey Questions;
- Pg. 32 Added copy of Business Survey Questions;
- Pg. 37 Added copy of Rider Survey Questions;
- Pg. 47 Added Metro Ride Regular and Express route maps to Appendix C.

Seubert gave recognition to Mack and Lynch for all their work. Every 5 years the MPO creates a TDP for the Wausau metropolitan area.

Action: MOTION / SECOND BY LENZ / MULLALEY TO ADOPT THE 2018 TRANSIT DEVELOPMENT PROGRAM FOR THE WAUSAU METROPOLITAN AREA. MOTION CARRIED BY VOICE VOTE, NO DISSENT. Follow Through: Staff will inform the area municipalities the TDP was adopted and also present it to the Wausau Transit Commission.

RESOLUTION ADOPTING THE AMENDMENT TO THE 2018-2021 TRANSPORTATION IMPROVEMENT PROGRAM FOR THE WAUSAU METROPOLITAN AREA

- **WHEREAS,** the Marathon County Metropolitan Planning Commission was designated the Metropolitan Planning Organization for the Wausau Urbanized Area; and
- WHEREAS, in compliance with Metropolitan Transportation Planning Regulations by the U.S.

 Department of Transportation, the Marathon County Metropolitan Planning
 Commission has developed a four-year transportation improvement program
 (TIP) for the Wausau Metropolitan Area; and
- WHEREAS, the Transportation Improvement Program identifies transit, pedestrian/bicycle, and highway improvement projects and programs consistent with current transportation plans;
- **NOW, THEREFORE, BE IT RESOLVED,** that the Marathon County Metropolitan Planning Commission endorses the *Long Range Transportation Plan for the Wausau Metropolitan Area* and the *Transit Development Program for the Wausau Area Transit System,* which will be continually updated and maintained as part of the urban transportation planning process;
- **BE IT FURTHER RESOLVED,** that the Marathon County Metropolitan Planning Commission adopts the STH 29 CMC Retrofit Barriers project and the WI Auto and Truck Education Association Vehicle Loan Program amendments to the 2018-2021 Transportation Improvement Program for the Wausau Metropolitan Area; and
- **BE IT FURTHER RESOLVED,** in accordance with 23 CFR 450.336, the Wausau Metropolitan Planning Organization for the Wausau, WI urbanized area hereby certifies that the metropolitan transportation planning process is addressing the major issues facing the metropolitan planning area and is being conducted in accordance with all applicable requirements of:
 - 1. 23 U.S.C. 134 and 49 U.S.C. 5303, and this subpart;
 - 2. Sections 174 and 176 (c) and (d) of the Clean Air Act as amended (42 U.S.C. 7504, 7506 (c) and (d)) and 40 CFR part 93;
 - 3. Title VI of the Civil Rights Act of 1964, as amended (42 USC 2000d-1) and 49 CFR part 21:
 - 4. 49 USC 5332, prohibiting discrimination on the basis of race, color, creed, national origin, sex, or age in employment or business opportunity;

- 5. Section 1101(b) of the Fixing America's Surface Transportation (FAST Act) (Pub. L. 114-357) and 49 CFR Part 26 regarding the involvement of disadvantaged business enterprises in the US DOT funded projects;
- 6. 23 CFR part 230, regarding the implementation of an equal employment opportunity program on Federal and Federal-aid highway construction contracts;
- 7. The provisions of the Americans with Disabilities Act of 1990 (42 U.S.C. 12101 *et seq.*) and 49 CRF Parts 27, 37, and 38;
- 8. The Older Americans Act, as amended (42 U.S.C. 6101, prohibiting discrimination on the basis of age in programs or activities receiving Federal financial assistance;
- 9. Section 324 of title 23, U.S.C. regarding the prohibition of discrimination based on gender; and
- 10. Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794) and 49 CFR 27 regarding discrimination against individuals with disabilities.

BE IT FURTHER RESOLVED, that the Marathon County Metropolitan Planning Commission certifies that the Transportation Improvement Program contains only projects that are consistent with the transportation plan for the urban area and recommends that this document be submitted to the appropriate federal and state agencies for approval.

SUBJ: 2019-2022 STP – Urban Program Cycle

The 2019-2022 STP¹ – Urban Program Cycle is moving forward.

STP - Urban Program Policy Protocols

The STP-Urban Program is a federally funded local program. Funds distribution and project eligibility remain largely unchanged from prior program cycles. While the department has made roadway preservation improvements a funding priority in other local and state programs, the WisDOT STP-Urban Program can fund federally eligible transportation related activities as approved by the Regional Planning Commission (RPC) processes; except for bicycle/pedestrian personnel positions.

STP funding allocations to Wisconsin Urbanized Areas are set at the beginning of a program cycle; no additional funding is provided during the program cycle. Funds Available Allocations for each program cycle are determined by federal apportionment, annual state budget appropriation limits², urbanized area population, and current programming. Due to the program delay, the current program cycle is utilizing four full years of funding and current programming, state fiscal years 2019 – 2020, instead of five years to arrive at Funds Available for each RPC, effectively dropping fiscal year 2018 which closes on June 30th. Attached is the 2019-2022 Program Funds Available Estimate for the STP-Urban Program.

The federally funded program will continue to adhere to standards as stipulated in the WisDOT Facilities Development Manual (FDM), retain full WisDOT oversight, and projects will be state Let for construction. WisDOT project oversight costs are expected to decrease due to the elimination of the use of Management Consultants (MCs) to deliver the local program. WisDOT Region staff are available to assist in project design and construction oversight estimates.

Change Management

Because urbanized areas receive a fixed funds allocation each program cycle, federal funding for all urbanized area projects is capped at a cost share determined by the RPC. RPC Transportation

Improvement Program (TIP) Committees may approve project federal funding from 50% up to an 80% maximum cost share at the time of project application approval.

The department's Change Management policy accommodates appropriate schedule changes and project substitutions to approved projects in coordination with the RPC as the approved project progresses through the design process.

2017-2022 Surface Transportation Program - Urban Timeline

Program applications were submitted by local public agencies in the spring and early summer of 2017. The department recognizes that RPCs may need additional time to coordinate and update project application information with the local project sponsor. The review of current applications by RPCs, including coordination with WisDOT staff to determine delivery oversight estimates, is expected to take six to eight weeks. Please return all selected project applications to WisDOT no later than **August 8, 2018**.
